


#### Funding: \$341K/year\*



McDougall	Ogden	Red Deer Lake
Provides their 50%, collects from Ogden and Red Deer Lake, then pays Joanne, Bill & Danah	Ogden transfers their 8% portion to McDougall	RDLUC pays Grant's .25 FTE directly & transfers the remainder of their 42% portion to McDougall
